- **For candidates working in Govt./PSU:** The candidate should have minimum 20 years post qualification experience in Finance & Accounts, out of which minimum 2 years working experience in the grade of Rs. 37,400-67,000 (CDA) (with grade pay of Rs. 8700 equivalent to IDA Pay scale 36,600-62,000/-) or in the pay scale of Rs. 36,600-62,000 (IDA)

- **For candidates working in Private Sector:** The candidate should have minimum 20 years post qualification experience in Finance & Accounts, out of which atleast 2 years working experience in the CTC of Rs. 20 lacs per annum in a company having its turnover of over Rs. 200 Crores.
