In continuation to our earlier Advertisement No: 17/SPSC/2015 dt: 13/05/2015 and Notice No: 92/SPSC/2015 dt: 06.06.2015 the Sikkim Public Service Commission hereby invites applications in prescribed forms from the eligible candidates for filling up of 04 (four) posts of Principal of Sikkim Government Colleges, (Namchi, Gyalshing, Burtuk & Rhenock) plus 02(two) additional posts of Principal in Sikkim Government Law College (Burtuk) and Sikkim Sanskrit Mahavidalaya (Samdong) in the PB-5 of Rs. 37400-67000 plus Academic Grade Pay (AGP) of Rs. 10,000/- under Human Resource Development Department, Government of Sikkim through Direct Recruitment.

Application form should be supported by a copy of all requisite documents duly attested and No Objection Certificate from the appointing Authority. The amount once deposited shall not be refunded or adjusted against any other purpose.

One Stamp size photograph should be affixed on the application form in the space provided and two identical stamp size photographs with the applicants name on the back side of the photograph should be submitted along with the application form.

No application submitted after **03.00 pm. on 23/09/2017** will be accepted. SPSC will not be responsible for late receipt of application due to postal delay or otherwise.

Applicants are advised to go through the Advertisement scrupulously and fill in the form accordingly.

No TA/DA is admissible for attending the examination/Interview.

**Admission at all the stages of examination for which applicants are admitted by the Commission viz. Interview Test will be purely provisional and is subject to satisfying the prescribed eligibility conditions. If, on verification at any stage of the examination process, it is found that applicant do not fulfill any of the eligibility conditions, their candidature for the post will be cancelled by the Commission without notice.**
